(without aid) w.e.f. academic session 2006-07.

Sir,

With reference to your application on the subject noted above, I am directed to convey the approval of the Director of Education, Delhi to grant recognition from Ist to Xth (without aid) w.e.f. academic session 2006-07 subject to fulfillment of following terms & conditions :-

01. That the school shall abide by the provisions of Delhi School Education Act & Rules, 1973 framed thereunder as well as the instructions issued from time to time.
02. That the school shall admit students without any discrimination of caste & creed and preference shall be given to the students of the area concerned.
03. That the school shall equip the science Lab. as per the norms of the Department and suitable facilities for practical work shall be provided to the students and a list be furnished to the concerned Education Officer for verification.
04. That a proper library shall be established and facilities for reading room shall also be made available for students as well as teachers. More approved standard books shall be purchased. Books as per the ratio of 10 books per student may be added and list be furnished to the concerned Education Officer for verification.
05. That the adequate sports material shall be purchased for out door games and indoor games.
06. That the school shall strictly abide by the provisions of DSEAR, 73 and payment shall be made as per section 10(1) of DSEAR, 73 to all the employees through crossed cheque and proof should be shown to the concerned Education Officer.
07. That the enrollment in each section shall not exceed the number of students calculated @ 10 sq. ft. per student for the available area of the class room and the school shall provide adequate and sufficient accommodation as per norms of the Department in each class. The number of existing section should not exceed the number of class room of proper size in the school.



08. That the school shall not run any unrecognised classes or any other activity within the school premises and all the recognised classes shall be run under the banner of the recognised school.
09. That all the facilities prescribed under Rule 50 & 51 of DSEAR, 73 shall be made available to the students, provision of Rule 6, 7 & 9 be strictly observed.
10. That the service contract between the management and the employees shall be executed immediately.
11. That the arrangement of good drinking water shall be made available to all the students as well as to the teachers/ staff and sanitary facilities shall also be provided to the students adequately.
12. That the violation of any instruction/order/conditions/rules & regulations of the Department shall lead to the withdrawal of recognition approval of the Directorate of Education.
13. That the management of the school shall provide all the facilities as per Rule 50 and all conditions as required under Rule 51 shall be complied with.
14. That the management of the school shall create a reserve fund equal to 03 months salary of the staff in a joint name of Director of Education and the Manager of the school in any scheduled Bank within a month.
15. That a report about the fulfillment of the above conditions giving the extent to which each condition is fulfilled shall be sent to the concerned Education Officer every six months.
16. That the school will appoint the requisite qualified staff as per recruitment rules and post fixation norms of the Department. Further the school will remove the unqualified and overaged staff immediately and proof thereof should be provided to the concerned Education Officer for verification.
17. That the school will follow the approved courses of study prescribed by the Department.
